GOLD

In 2014, the largest ever number of Scottish girls took part in Guiding Overseas Linked with Development, or GOLD.

Ten Girlguiding Scotland members went on the trip of a lifetime to Cambodia, The Gambia, Guyana, Latvia, Malawi, Peru and Sri Lanka.

Founded in 1991, GOLD offers young women between the ages of 18 and 30 the chance to develop their potential, improve their skills and make a long-lasting positive difference in communities as far afield as Honduras, Madagascar, Russia, South Africa and Thailand.

Girlguiding Forth Valley member Emma
Guthrie wrote about her GOLD trip to The
Gambia in Third Force News. She said: "My
team was excellent - we were put together
at an international selection weekend but from The Gambian experience the
everlasting memory is the dancing. I've
never danced so much. We would plan
sessions to finish at a certain time and many
hours later we would still be dancing!"



Big Brownie Birthday

Girls from across Scotland partied in all sorts of wacky and wonderful ways throughout 2014 to mark 100 years of the Brownies.

Edinburgh Brownies took over the Scottish National Museum where they boogied the night away in a silent disco and 4,000 Brownies took part in a Birthday Fun Day at Gleneagles where they tried out an inflatable obstacle course and learned circus skills.

600 girls from Dunbartonshire celebrated with an extra-special sleepover at the Glasgow Science Centre and in May, 300 Brownies travelled to Netherurd or Templars' Park for the two action-packed Big Brownie Birthday Bash weekends.

Engaging in the democratic process

As the biggest charity for girls and young women in Scotland, we play a key role in helping our members speak out and make their voice heard.

Girlguiding Scotland encouraged all young women to make their voice heard in the independence referendum, and in June 2014 co-hosted a debate with the Scottish Youth Parliament where young women could explore the issues further.

The young women posed questions to a panel of prominent figures including Juliet Swann, from the Electoral Reform Society, the then-Minister for Children and Young People Aileen Campbell and Kezia Dugdale, then Shadow Cabinet Secretary for Education and Lifelong Learning.

Girlguiding Scotland also joined forces with other youth organisations to back votes for 16 and 17-year-olds in future Scottish elections. The call, covered by the Daily Record newspaper which also backed votes at 16, followed high levels of engagement amongst this age group in the Scottish independence referendum.

Fast-Track Leadership Qualification weekend

It is thanks to our almost 11,500 volunteers that guiding happens - and the work they do is inspirational. In return, we offer our volunteers support, specialised training and the opportunity to develop new skills, meet new people and have fun.

In September 2014, 27 volunteers attended the Fast-Track Leadership Qualification weekend which allowed them to progress with their learning and gain support from others working towards their Leadership qualification.

New Brownie Leader Pamela Gibson, who attended the Fast-track Leadership Qualification weekend, said: "At the event we were in safe hands with the expert trainers who clearly live and breathe guiding on a daily basis - and their enthusiasm is infectious. I came away feeling more committed to guiding than ever and determined to do my best, as we say!"

Young Leader Qualification weekend

Becoming a Young Leader is a great opportunity for Senior Section members aged 14 - 18 to develop their leadership skills and take an active and positive role in guiding by helping to run a Rainbow, Brownie or Guide Unit.

In October 2014, 26 young women working towards their Young Leader Qualification took part in a weekend event to help them learn more about how they could use their Young Leadership Qualification with their Unit. The event aimed to boost their confidence and provide a fun way to meet others working towards their qualification.



Adventure 2014

In May 2014 more than 1,700 Guides and Senior Section members got the chance to experience a day of fun and exciting outdoors activities through Adventure 2014.

With the help of Cashback for Communities funding, which invests money recovered from the proceeds of crime into activities for young people, Girlguiding Scotland delivered affordable adventure events to girls and young women who may not otherwise have had the opportunity.

Those who took part stretched themselves to the limit and learned new skills trying out a wide range of challenging activities from abseiling, mountain biking and windsurfing, to caving and whizzing down a zip-wire.

Adventure 2014 took place at four centres spread across Scotland including our very own at Netherurd Training and Activity Centre in the Scottish Borders and centres in Fife, Kirkudbrightshire and Ross-shire to enable as many girls as possible to join in.

One mum said: "The Guides is the best thing that has happened to my daughter, who lacks confidence. These adventure days are wonderful for encouraging her to mix with others and try new things."





Queen's Guide Awards

The pinnacle of achievement for our Senior Section girls, aged 16 to 25 years, is the Queen's Guide Award. Participants undertake a series of challenges that are designed to give Girlguiding sustained service, be of benefit to the community and develop personal skills. Treasurer's report 2014

In many respects 2014 was a quieter year financially with no Tartan Gig and the conclusion of the historic VAT issues. This disguises the fact that in general it was a better year than anticipated with the retail activity outperforming budget by £25,000 to achieve a £40,000 surplus, partly due to the Big Brownie Birthday and a range of badges. Although Netherurd recorded a deficit of £9,000 this was £6,000 less than budget and considerably less than in 2013.

Membership subscriptions are our main source of income and crucial to ongoing guiding activities, They represent 55% of income, excluding trading income. With an increase in new Units, hopefully this will translate into increased membership for the future.

As ever there were a number of minor over and underspends on our general activities which, coupled with the improved position in relation to retail and Netherurd, allowed us to allocate additional funds at the year end, primarily providing additional resources to support areas such as travel and qualifications as well as property and IT. During 2014 we initiated a major review of Netherurd and final decisions will be made in 2015 which could have a significant impact on our reserves over the next 18 months.

Despite the economic pressures felt by many we continue to attract grant support for a range of our activities, for example through Girlguiding and the Scottish Government. For the future it is crucial to continue to fund our work to grow the membership so that, should such funding decrease, will we continue to have adequate resources.

This year I can conclude that the future truly looks bright.
